Award: Up to \$5 million or 80% of the total project cost

Match Requirement: 20% minimum

April 11, 2024 – Letter of Intent (LOI) due by 5:00 p.m. CT

April 11, 2024 – Application window opens

May 2, 2024 – Application Submissions Due at 5:00 p.m. CT

Eligible Applicants

Current Internet Service Providers (ISP), including:

- Cooperatives
- Corporations
- Limited Liability Companies
- Partnerships
- Non-profits
- Other private business entities
- Units of government

Eligible Areas

- Areas not included within the boundaries of any incorporated city or town having a population in excess of 25,000 inhabitants
- Area without a service provider who is either providing at least 100/20 Mbps or will provide those speeds during a similar timeframe as required by another state or federal grant

Eligible Projects

 Must provide at least one service offering capable of delivering broadband service that reliably meets or exceeds 100/100 Mbps to customers in rural, unserved areas of Alabama

Eligible Costs

- Repair, rehabilitation, construction, improvement, and acquisition of broadband infrastructure
- Long-term leases (greater than one year) of facilities required to provide broadband service for the project (including indefeasible right-of-use agreements and capital leases)
- Project-deployment personnel-related costs

Note: Operating costs, indirect costs, and any costs incurred before or after the term of the CPF subaward agreement are not eligible for reimbursement

Selection Criteria

Scoring (maximum of 145 points):

- Critically Unserved Area Bonus up to 10 points
- Project Description up to 25 points
- Technical Assistance Bonus up to 10 points
- Leverage up to 10 points
- Extension up to 10 points
- Community Support up to 10 points
- Efficient Outcome up to 10 points
- Hospitals up to 10 points
- Libraries up to 10 points
- Adoption up to 10 points
- Applicant MBE/DBE up to 10 points
- Underrepresented and Historically Disadvantaged up to 10 points
- Labor up to 10 points

Application Process

- Applicants must submit a LOI including applicant's contact information and a shapefile of the proposed project area (shapefile must use a polygon format)
- LOIs are to be submitted via email to broadband.fund@adeca.alabama.gov
