Funding Amount

Up to \$2 billion from California Appropriations and American Rescue Plan Act (ARPA) funds

Key Dates

- June 30 Application Window Opens
- July 6 FFA Application Process Webinar: Register Here
- September 29 Application Window Closes at 4 pm PDT
 - Applications accepted on a rolling basis every six months as long as funding is available
 - California Public Utilities Commission (CPUC) staff will review applications in no more than 6 months
 - Organizations will have 14 days to file objections to applications

Eligible Applicants

- Entities with Certificate of Public Convenience and Necessity (CPCN) that qualify as a "telephone corporation"
- Non-telephone corporations that are facilities-based broadband service providers
- Local governmental agencies
- Electric utilities
- Non-profits
- Cooperatives
- California Tribes

Eligible Areas

Unserved Area – no access to speeds of at least 25/3 Mbps

Eligible Projects

Maximum grant request is \$25 million

Selection Criteria

- Match up to 10 points
- Project Technology Choice up to 10 points
- Type of Partnership up to 20 points
- Offers California LifeLine and/or Federal Lifeline up to 10 points
- Pricing Commitment up to 10 points
- Offering low-cost broadband plan at 50/20 Mbps up to 20 points
- Existing broadband service need up to 20 points
- Applicant capacity and performance up to 10 points
- Technology, Network, and Budget up to 10 points
- Leveraging Statewide Middle Mile up to 10 points

Buildout Requirements

- Funded projects must deliver 100/100 Mbps
 - Unless significant topographic, geographic, or financial impracticability exists
- Projects shall be completed within 24 months after receiving authorization to construct
 - CEQA exempt projects must be completed in 18 months
- Applicants commit to serve customers in project area at prices not exceeding those provided in application for 5 years after project completion
- Projects shall provide service at no higher than 100 milliseconds of latency
- Data caps are strongly disfavored; indication the proposed infrastructure is insufficient
- Projects shall participate in the Affordable Connectivity Program (ACP)

Middle Mile

 Middle mile connections will be considered but applicants are encouraged to focus on last-mile connections

Eligible Costs

- Costs directly related to the deployment of infrastructure
- Costs to lease access to property or for Internet backhaul services for a period not to exceed 5
 years
- Costs incurred by an existing facility-based broadband provider to upgrade its existing facilities to provide for interconnection
- Costs incurred during the period beginning March 3, 2021, and ending December 31, 2024
- Administrative expenses directly related to the project are capped at 2% of the grant amount
