Affordability and Adoption Assistance

- Low Price Service Tier 10 points
- Commitment to Improving the Adoption Rate 15 points

Maximum Points Available – 500 points

- Eligibility for funding is based on scoring a minimum of 250 points
- Highest scoring will be for areas below 10/1 Mbps and 25/3 Mbps are provided with 1G/1G without data caps and with a low income 100/100 Mbps \$0 ACP program lowincome service tier

Middle Mile

- Middle mile connections that facilitate last mile connections are eligible
 - Applicants should identify one or more last mile partners who will deploy service to unserved locations
 - Middle mile applications will be evaluated using the same scoring criteria used to score last mile applications

Buildout Requirements

- Required to expend funds by December 31, 2026
- Applicants must offer one low-cost option without data usage caps, at speeds sufficient for a multiple user household to simultaneously engage in telework and remote learning
- Infrastructure must deliver service that reliably meets or exceeds 100 Mbps symmetrical
- · Priority given to fiber-optic networks

Eligible Costs

- Pre-project but post-award, development cost and uses, including data-gathering, feasibility studies, community engagement and public feedback processes, equity assessments and planning, and needs assessments
 - Includes: permitting, planning, architectural design, engineering design, and work related to environmental, historical, and cultural reviews
- Costs of repair, rehabilitation, construction, improvement, and acquisition of real property, equipment, and facilities (e.g., telecommunications equipment, including infrastructure for backhaul and last mile networks)
- Cost of long-term leases, including indefeasible right-of-use ("IRU") agreements and capital leases
- Personnel costs including salaries and fringe benefits for staff and consultants required for the project
- Costs to increase broadband adoption and improve digital literacy
- Compliance costs associated with monitoring of and reporting on projects, including award closeout costs

Ineligible Costs

- Costs associated with completing or filing a grant application
- Any expense incurred prior to the formal acceptance and execution of the grant agreement
- Acquisition of spectrum licenses
- Operating expenses
- Short-term operation leases
- Payment of interest or principal on outstanding debt instruments
- Fees or issuance costs associated with the issuance of new debt
- Satisfaction of any obligation arising under or pursuant to a settlement agreement, judgment, consent decree, or judicially confirmed debt restructuring plan in a judicial, administrative, or regulatory proceeding
