- The State has identified 44 preliminary eligible unserved project areas
- Final eligible project areas will be announced following the Challenges to the Proposed Eligible Areas Process August 26 at 5:00 PM ET

Eligible Projects

Projects must meet the following criteria:

- Directly enables work, education, and health monitoring
- Addresses a critical need that resulted from, made apparent, or exacerbated by the COVID-19 public health emergency
- Addresses a critical need of the community

Presumptively Eligible Project

- Broadband Infrastructure Projects
- Digital Connectivity Technology Projects
- Multi-Purpose Community Facility Projects

Mapping Issues

- Final eligible project areas will be announced following the Challenges to the Proposed Eligible Areas Process August 26 at 5:00 PM ET
- Service providers can file a Service Verification Form if they believe that a proposed eligible project location overlaps with their current service network.
 - Documentation required to show active buildouts

Scoring Criteria

- Project Design and Implementation 25%
 - Project timeline required
 - Preference given to projects prioritizing fiber-optic infrastructure investments
- Capabilities and Competencies 20%
- Performance Measures 10%
- Project Budget (including matching funds) 30%
 - Amount of grant funds requested, a detailed budget, and matching funds must be submitted using the provided budget template
 - Preference given to applications with higher matching funds
- Community Engagement 10%
 - Including letters of support from local governments, elected officials, residents, public surveys, etc.
- Affordable Offering 5%
 - Preference given to applications that provide at least one low-cost, affordable option offered minimum of 100/20 Mbps



Buildout Requirements

- 100/100 Mbps
- If a project cannot deliver services of at least 100/100 Mbps, the project must be designed so that it reliably meets or exceeds 100/20 Mbps and be scalable to a minimum of 100/100 Mbps
- Must participate in the Affordable Connectivity Program (ACP)
- Must participate in the Georgia Broadband Map program and submit regular network updates as requested by the State
- All funds must be expended by December 31, 2026

Eligible Costs

- Capital expenses directly related to deployment of a qualified broadband project
- Materials
- Supplies
- Equipment
- Construction of "last-mile" infrastructure
- Pre-project development costs and uses
 - Data gathering
 - Feasibility studies
 - Engineering design
 - Work related to environmental & historical preservation
 - Cultural reviews
 - Permitting
- All remaining pre-project costs are eligible under matching funds

Ineligible Costs

- Acquisition of spectrum licenses
- Operating expenses
- Short-term operation leases
- Satisfaction of any obligation
- Payment of interest or principal on outstanding debt instruments
- Fees or issuance costs associated with the issuance of new debt
- Maintenance expenses
- Infrastructure not directly connected to service provision for an end-user in the proposed area
- Indirect labor costs (fringe/benefits, travel, meals, lodging, paid time off, etc.)
 - Long term capital asset purchases/leases (cost allocation for use during project period to be considered on case-bycase basis)
