Funding Details

- 100% Loan Up to \$200M, 2% fixed interest rate, max. request \$50M
- 50% Loan/50% Grant Combo Up to \$100M for loans and \$100M for grants, max. request \$25M loan, \$25M grant (loan and grant amounts always equal)
- 100% Grant Up to \$150M, match of 25%, max. request \$25M
- 100% Grant for Tribal Governments, Alaska Native Corporations, Colonias, Persistent Poverty Areas, and Socially-Vulnerable Communities – Up to \$150M, no match, max. request \$25M

Eligible Areas

- 90% of the PFSA must lack sufficient access to broadband service of at least 25/3 Mbps
- Areas with population densities of 6 or less per square mile or if the PFSA is located 100 miles from a city or town of greater than 50k population

Eligible Projects

- Proposed network must be capable of providing 100/100 Mbps to every premise in PFSA
- Project must be completed within 5 years from the date funds are available

Eligible Costs

- Construction or improvement to facilities to provide fixed broadband service
- Reasonable preapplication expenses in an amount not to exceed 5% of award
- Acquisition and upgrading of an existing system that does not currently provide sufficient access to broadband

Scoring Criteria

Scoring (maximum of 150 points):

- Rurality of PFSA 25 points
 - For population densities of 6 or less/sq mile, or if PFSA is at least 100 miles from a city or town of greater than 50k population, full points will be awarded
- Economic Need of Community 20 points
 - Economic need based on the county poverty percentage of the PFSA determined by utilizing the Census Small Area Income and Poverty Estimates (SAIPE) Program
 - If 75% of a PFSA(s) covers communities with a SAIPE score of 20% or higher, full points will be awarded
 - Tribal applicants can request alternative scoring consideration by submitting more granular Tribal specific census data using the <u>census.gov/tribal</u> tool

• Affordability – 20 points

- Applications must include one low-cost option offered at speeds that are sufficient for a household with multiple users to simultaneously telework and engage in remote learning
- Labor Standards 20 points
 - Description of strong labor standards, such as prevailing wage, safety training, professional certifications, workforce development, etc

• Tribal Areas – 15 points

- Applicants that are Tribal entities with PFSAs that are at least 75% on tribal lands receive full points
- Non-tribal entities with PFSAs serving at least 50% of tribal lands receive 10 points

Scoring Criteria Cont.

- Local Governments, Non-Profits, and Cooperatives
 – 15 points
 - Applications submitted by local governments, non-profits, or cooperatives (including for projects involving public-private partnerships where the local government, non-profit, or cooperative is the applicant)
- Socially Vulnerable Communities 15 points
 - Applications where at least 75% of the PFSA(s) are proposing to serve Socially Vulnerable Communities
- Net Neutrality 10 points
 - Applicants that commit via board resolution, or equivalent, to net neutrality principles (i.e., will not block or impair/degrade lawful traffic or engage in paid prioritization
- Most Unserved Locations Per Square Mile up to 10 points
 - Unserved locations contained in the FCC's Broadband Serviceable Location Fabric that lack access to a wired or licensed fixed wireless at speeds of at least 25/3 Mbps
 - Projects with at least 75% of PFSA(s) located in states ranked 1-5 receive full points: Alaska, Idaho, Montana, New Mexico, and Wyoming
 - Projects with at least 75% of PFSA(s) located in states ranked 6-10 receive 5 points: Arkansas, Mississippi, Nevada, South Dakota, and West Virginia
 - Projects with 75% of PFSA(s) located in more than one of these states will receive the points associated with the highest scoring state
