ConnectME Broadband Infrastructure Grant Program

#### **Funding Amount**

\$6.5 million drawn from state bond approved by voters to expand availability of broadband service in Maine.

#### **Key Dates**

1/12/22 - Application Window Opens 3/20/22 - Application Deadline at 11:59 PM EST

#### **Eligible Applicants**

- One or more multiple entities from the private and/or public sectors include the following entities:
  - Communications Service Providers/Internet Service Providers
  - A unit of local government, including town, city, county or regional council of governments
  - A broadband utility district or corporation, wholly or partially owned by unit of local government

### **Eligible Areas**

- Unserved Area no service of 50/10 Mbps
- Underserved Area broadband service of 50/10 Mbps or greater but less than 100/100 Mbps, from two providers

### **Eligible Projects**

- **Subscriber Location** any location with one or more communications subscribers including: a house, apartment, apartment complex, condo complex, other dwelling unit, a business, business complex, medical facility, community building, government facility, or other facility
- Projects must serve subscriber locations in unserved or underserved areas
- Minimum financial commitment of \$700 per subscriber location
- Total financial commitment is equal to total project cost minus grant amount requested, divided by number of subscriber locations to be served
- The number of potential subscriber locations must include all of the following counts within the project area(s):
  - Subscriber locations within the unserved areas
  - Subscriber locations within unserved areas to be served by project
  - Subscriber locations within served areas to be served by project

#### **Buildout Requirements**

- Projects of less than \$1.5 million must be completed within one year of initial funds disbursement, or within 180 days of necessary licenses, permits and governmental approvals, whichever is later, unless an extension is approved
- Projects that are over \$1.5 million will have a contractually agreed to completion date

#### **Mapping Issues**

- Use of VETRO FiberMap is required to select a project area from unserved and underserved areas identified by ConnectMaine as eligible. FiberMap will contain eligible project areas and a layer of potential subscriber locations, classified as unserved, underserved or served areas
- Use FiberMap to outline the following:
  - Project Area select one or more project area(s)
  - Proposed Design Design must include fiber routes (including fiber strand count) and interconnection with existing networks
  - Project Focus Identify potential subscriber locations in the project area, identify each as being unserved, underserved or served areas
- VETRO will provide a FiberMap user guide upon request
- Maine Broadband Availability Map
- <u>ConnectME Broadband Mapping</u>

#### **Application Contents**

- Grants Portal (Legal Applicant, Executive Summary, Project Information)
- Interactive FiberMap (Proposed Area, Design, Focus)
- Application Data Form
- Application Narrative
- Supplemental Files

#### Scoring

- ConnectMaine will give preference to projects in unserved and underserved areas that provide the greatest relative improvement to existing internet service. The three preference groups:
  - 1. Least Served: Project areas where a majority of subscriber locations lack service of at least 25/3 Mbps
  - 2. Greatest Improvement: Projects proposing to offer at least 90% of subscriber locations broadband service of at least 1/1 Gbps
  - 3. All other proposed projects

### Scoring (continued)

- Preference Criteria
  - Cost-Benefit
    - Applications are judged based on the cost-benefit of the proposed project
    - An unweighted cost-benefit is calculated as the grant amount requested divided by the number of potential subscriber locations in unserved and underserved areas to be served by the project
  - Project Scope
    - Density of Project Area
    - Community Financial Commitment
    - Applicant Financial Commitment
  - Project Value
    - Subscription Prices
    - Affordability Offering

#### **Budget Categories**

- Professional Services
- Outside Plant
- Drop and Customer Premise Equipment
- Network and Access Equipment
- Wireless
- Long-term Leases

#### **Allowable Costs**

- Eligible project costs include:
  - Professional Services including engineering, permitting, easements and encroachment acquisition, project and construction management
  - Outside Plant including fiber optic and coaxial cable, pole placement and pole make-ready, aerial and underground materials, and aerial and underground construction labor
  - Drops and CPE service drops and other costs of connection up to network interface points, including subscriber connection materials, subscriber connection equipment, subscriber connection labor, subscriber management equipment
  - Network and Access Equipment including headend, central office, or remote cabinet equipment and installation
  - Land and Buildings including equipment shelters, land, site preparation and site restoration costs
  - Wireless Equipment and Facilities including towers, tower improvements and installations, backhaul and access radios, and powering equipment
  - Long-term Leases with term not less than one year, including land required for network, building or space to house network equipment, and network elements such as dark fiber
  - Ineligible costs include but aren't limited to:
    - Expenses incurred prior to date of awarded grants announcement
    - Administrative and fundraising activities, computers and other office equipment, vehicles and other operating expenses
    - Equipment owned or leased by the subscriber, including routers, modems and other costs beyond the network interface points
    - Operating expenses
